APPROVING THE APPLICATION FOR ACCREDITATION OF *PROTECT MARINE DECK AND ENGINE OFFICERS OF THE PHILIPPINES, INC.* AS TRAINING PROVIDER FOR THE MANAGEMENT LEVEL COURSES FOR MARINE DECK AND ENGINEER OFFICER




