**ESTABLISHING THE POOL OF
MTC INTERNAL QUALITY AUDIT TEAM**

WHEREAS, Section 1 of Letter of Instructions (LOI) No. 1404 dated May 1, 1984 provides that the Maritime Training Council (Council) shall be established to give effect to the 1978 International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, as amended;

WHEREAS, Executive Order No. 242 dated May 12, 2000 was issued to restate and clarify the authority of the Council as the agency responsible in the implementation of the 1978 STCW Convention, as amended;

WHEREAS, one of the responsibilities of the Council under paragraph 1.2 of Executive Order No. 242 is to ensure that the evaluation of the Quality Standards System (QSS) of its member agencies shall be conducted in accordance with paragraph 2 of Regulation I/8 of the 1978 STCW Convention, as amended;

WHEREAS, the Council issued Resolution No. 05, series of 2005, entitled "Establishing Guidelines in the Implementation of Regulation I/8 of the STCW Convention, as amended, and Section A-I/8 of the STCW Code";

WHEREAS, the Council issued Resolution No. 05, Series of 2007, entitled "Approving the National Quality Standards System";

WHEREAS, the National Quality Standards System warrants a yearly Internal Quality Audit (IQA); and

WHEREAS, there is a need to designate a pool of Internal Quality Audit Team which will conduct the Internal Quality Audit for the year 2009 in accordance with the Guidelines for the MTC Internal Quality Audit stated in Annex 1 of MTC Resolution No. 06, series of 2007;

NOW THEREFORE, in consideration of the foregoing premises, the Council **RESOLVES**, as it hereby **RESOLVED**, that the following shall comprise the pool of Internal Quality Audit Team:






